## Appointment

1.1 The Company hereby appoints IB Client as an IB to introduce and refer potential clients ("Referrals") to the Company's Forex brokerage services.

1.2 IB Client accepts the appointment and agrees to act as an independent contractor, promoting and marketing the Company's services to potential Referrals.

## Duties and Responsibilities

2.1 IB Client shall undertake reasonable efforts to introduce Referrals to the Company, providing accurate and fair information about the Company's services.

2.2 IB Client shall comply with all applicable laws, regulations, and industry standards in its promotional activities and client interactions.

2.3 IB Client shall not provide investment advice or engage in any activity that requires regulatory authorization unless otherwise agreed in writing with the Company.

## Compensation

3.1 The Company shall compensate IB Client based on a mutually agreed commission structure set forth in a separate commission agreement or schedule.

3.2 Commissions shall be paid to IB Client based on the trading volume generated by Referrals, subject to the terms and conditions specified in the commission agreement.

## Client Referral Process

4.1 IB Client shall follow the Company's established client referral process, which may include providing unique tracking links, utilizing designated marketing materials, or using a specified code to ensure proper tracking and identification of Referrals.

4.2 The Company shall track, and monitor Referrals using the designated referral process and provide IB Client with periodic reports outlining the trading activity and commissions earned by Referrals.

## Confidentiality

5.1 The Parties agree to maintain the confidentiality of any proprietary or confidential information received from each other during this Agreement.



5.2 IB Client shall not disclose any confidential information received from the Company to any third party without the Company's prior written consent, except as required by law.

## Terms and Termination

6.1 This Agreement shall commence on the effective date stated below and shall continue until terminated by either Party upon [number of days/months/years] written notice to the other Party.

6.2 The Company reserves the right to terminate this Agreement immediately, without prior notice, in the event of a breach of any terms of this Agreement by IB Client.

## Governing Law and Jurisdiction

7.1 This Agreement shall be governed by and construed in accordance with the laws of [Jurisdiction]. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of [Marshall Island].
